## Pertinent T&Cs:

### Driving:

1. Any driver must hold a full licence relevant to the vehicle being driven
2. Any driver must have held a relevant licence for at least 12 months
3. Any driver must have a clean licence with no penalty points, endorsements or convictions
4. The driver must hold a valid licence for the type of vehicle being driven regardless of whether such licence is not required in the particular circumstances/location of the vehicle use.

### Vehicle Usage:

1. Excluding carriage of passengers &/or goods for hire or reward
2. Excluding stunt driving or hazardous driving unless prior referral and agreement received from Insurers.
3. Vehicle must be driven and passengers carried in accordance with the requirements of the Road Traffic Act at all times regardless of whether the RTA applies to the location &/or circumstances of vehicle use and all safety measures to be followed.

### Specific Exclusions:

1. Any damage to cameras, recording equipment, sound equipment, production equipment or computer equipment carried within or on the Insured vehicle.
2. Any damage to the insured vehicles caused directly or indirectly by the attachment of equipment to the insured vehicle.
